Course Description

This course aims to provide a framework to develop real-world machine learning systems that are deployed, reliable, and scalable. The focus of this course is to introduce basic modules of machine learning systems, namely, data management, data engineering, approaches to model selection, training, scaling, monitoring, and deploying to Machine Learning systems. (3 credit hours)

Description of Assignments

The course evaluation will be based on two exams and three project assignments.

Exams. The course exams will be based on Machine Learning concepts covered in class (see course schedule). No programming questions will be included in exams. The exam will comprise of a few multiple-choice or short answer questions, and a few computational questions where the students will need to perform some calculations to solve for an answer. Exams will not be cumulative.

Projects. The three projects will be defined by the course instructor and data will be provided by the course instructor. Each project will be based on concepts covered in the class (Project 1: Building & Evaluating Classifiers, Project 2: Unsupervised Learning, Project 3: Neural Networks). For each project, the students are expected to present a demo and to submit their code repository. The code should be uploaded to a software repository, such as GitHub, in a form that can be downloaded and run readily.
